We want your visit to BMW Welt, BMW Museum, BMW Group Classic and BMW Group Werk to be a very special experience. And of course this also means that you should feel entirely safe. That is why we have further increased our high standards.

For you as a guest: during your visit, you must observe the hygiene measures according to the Infection Protection Act. For guided tours: please note that the content and duration of our tours have been adapted to reflect these measures and may be restricted to selected areas if necessary.



HYGIENE.

Contactless hand sanitiser dispensers are available at all entry and exit points, outside the lifts in the toilets and in sections of the factory tour.



CLEANING.

Regular deep cleaning and disinfection of the exhibition vehicles, surfaces, event areas, our guide equipment and the sanitary areas.



SAFETY.

BMW Welt employees and on-site service providers have received training on the coronavirus regulations. Specialized staff monitors compliance with these, and also with the prescribed maximum number of visitors.



SOCIAL DISTANCING.

Queue markings will make it easier for you to comply with social distancing regulations.



FRESH AIR.

Our ventilation systems are optimally adjusted in all of our facilities.



INFORMATION.

All the important coronavirus information* can be found on notices at all entrances as well as outside and inside the lifts.

THE FOLLOWING PEOPLE ARE NOT PERMITTED TO ENTER BMW WELT.

1. Anyone with coronavirus symptoms such as a fever, sore throat, muscle/joint pain, cough or shortness of breath.
2. Individuals returning from a risk area in the last 10 days, or a "virus variant area" / "high incidence area" in the last 14 days (definition according to the Robert Koch-Institute) and who are or should be self-isolating.
3. Anyone who has had contact with someone who has been tested positive for coronavirus in the last 14 days and who is or should be self-isolating.

HERE IS WHAT YOU CAN DO TO HELP.

1. Wash your hands regularly and extremely thoroughly.
2. Wear a FFP2 face mask (this is compulsory**).
3. Maintain a minimum distance of 1.5 m from other people.
4. Please cough or sneeze into your elbow.
5. We are legally obliged in certain areas to register our guests to follow up possible chains of infection. This measure is subject to the GDPR.

**We would like to inform you that access to BMW Welt can only be granted to visitors wearing a FFP2 face mask. This also applies if a certificate of exemption is presented. We kindly ask for your understanding.
